Exports are a Vital Part of Illinois' Economy^A

- Preliminary Illinois exports totaled over \$65.90 billion in 2021. The preliminary agricultural adjusted figure for 2021 is \$70.57 billion.^c
- Since 2009, Illinois exports have increased by \$24.28 billion, or 58.3%
- Illinois is the largest exporting state in the Midwest and the 4th largest in the nation, a record, using agricultural adjusted figures provided by Census Bureau/ USDA cash receipts.^c
- 20 out of top 20 export industries increased 2020 to 2021
- 18 out of top 20 export industries increased 2009 to 2021
- Top 10 Illinois export industries have seen gains since 2009
- 9 of the top 10 Illinois export partner countries have seen gains since 2009
- Export activities support over 800K jobs in Illinois.^B

Total Trade between Illinois and Canada in 2021

- Illinois exports to Canada totaled \$18.38 billion in 2021, an 51.6% increase since 2009. Canada is Illinois' #1 largest export market
- Illinois ranks 4th among the 50 U.S. states in exports to Canada
- Illinois imports from Canada totaled \$45.26 billion in 2021, an 89.2% increase since 2009. Canada is Illinois' 2nd largest import market
- Illinois ranks #1 largest among the 50 U.S. states in imports from Canada
